During the tournament, players hear an audible alarm at the one-minute warning, and again to signify the end of the round. At the end of each round, the DB Dealer resets itself to the last setting used until the "Reset" button is pressed. Players can also pause and continue the blind timer at anytime during the round. When not in use, the DB Dealer automatically shuts off after two hours</p>

## APPENDIX A:

### OPERATING INSTRUCTIONS

**START/PAUSE BUTTON:** Press "start/pause" to start the timer. Press it again at anytime during the round to pause the timer. Press it again to restart the timer.

**SET BUTTON:** Press "set" at 0:00 to add time. Each time you press "set" it adds 5 minutes to the timer, up to 95 minutes.

**RESET BUTTON:** At anytime press and hold "reset" to rest time to 0:00.

**FEATURES:** The timer automatically returns to the previous set time at the end of each round. Simply press "start/pause" to begin the next round.

The timer will beep a warning at 1-minute. At the end of the round the timer beeps for 30 seconds, then automatically resets. To interrupt the beeping press any button. This returns the timer to the previously set time.

The timer will automatically shut off when not in use for 2 hours.
